Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier intimation dated 11th November, 2025, regarding the petition filed by M/s. Kamlesh Corporation ("Creditor") before the Hon'ble National Company Law Tribunal (NCLT), Mumbai, we hereby inform you that the Company has received an Order Sheet of Hearing (Hybrid) dated 28th November, 2025 received on 11th December, 2025 through e-mail from the Hon'ble NCLT Mumbai Bench.

In the said Order, the Hon'ble NCLT has granted the Applicant (Creditor) another opportunity to effect Dasti service of the Application and the Order upon the Company within a period of 15 days, and thereafter file an affidavit of service. The Company has been directed to file its reply within 7 days from the date of receipt of the served documents.

The matter has been adjourned and re-listed for further consideration on 05th January, 2026.

The Company has taken note of the directions and will act in consultation with its Advocate/legal counsel in the matter.
