Deep Industries before the Hon'ble Micro and Small Enterprises Facilitation Council (MSEFC), Ahmedabad, Gujarat, in continuation of the arbitration proceedings initiated under Section 18(3) of the Micro, Small and Medium Enterprises Development Act, 2006.

The said Statement of Claim pertains to the alleged delayed payment along with interest to the claimant as claimed under the provisions of the MSMED Act, 2006.

The Company is presently examining the contents of the said Statement of Claim in consultation with its legal advisors and shall take appropriate steps in accordance with applicable laws and within the prescribed timelines.
