Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier intimations dated 12th December, 2025 and 13th January, 2026 regarding the petition filed by M/s. Kamlesh Corporation ("Creditor") before the Hon'ble National Company Law Tribunal (NCLT), Mumbai, we hereby inform you that the Company has received on 19th March, 2026 the Order Sheet of Hearing (Hybrid) from the official website of the Hon'ble NCLT, Mumbai Bench.

As per the said Order, the Hon'ble Tribunal has taken on record the completion of service upon the Company. The Hon'ble Tribunal further noted that the Company had filed its reply with a delay and accordingly allowed condonation of delay subject to deposit of cost of Rs. 50,000/- in the Prime Minister's National Relief Fund (PMNRF) within a period of 7 days.

The matter has been adjourned and is now listed for hearing on 14th April, 2026.

The Company has taken note of the above Order and shall comply with the directions of the Hon'ble Tribunal in consultation with its legal counsel.
